While much of this progress occurred quietly and without widespread recognition, its effects have been profound for the entire state of Telangana.

Historically, SCSC's efforts were concentrated within the Cyberabad Police Commissionerate limits. However, the launch of the LECISO (Law **Enforcement Chief Information Security** Officers) Council marks a significant expansion. This council, which includes CISOs from major organizations across India, represents a strategic achievement for SCSC. Their shared mission is to create a cyber-safe ecosystem for Telangana, with aspirations of eventually extending these efforts across the country. The council is tackling the critical issue of underreporting cyber-attacks, which jeopardizes information security. By establishing a system for reporting and resolving cyber incidents, they aim to address the root of these problems and ensure comprehensive solutions. This initiative also facilitates international cooperation, particularly in dealing with cross-border cyber threats, by leveraging Interpol's resources through a collaborative approach between law enforcement and enterprises.



Additionally, SCSC has made remarkable strides in raising awareness about key issues such as cyber crimes, road safety, and women's safety. Over the past year, SCSC and Cyberabad Police jointly conducted 234 awareness sessions, reaching and positively impacting more than 100,000 individuals. These efforts underscore SCSC's commitment to enhancing safety and security in the region. Another big initiative that is making steady progress is setting up Safety Clubs across the schools and colleges in Cyberabad.

The continuous collaboration with the Cyber Security Bureau will further strengthen the Cyber Eco system across the country.

I am very optimistic about the coming year, and I wish a continued success and collaboration between SCSC and Cyberabad Police in the coming year, benefiting the industry and society as a whole.

The demand for Cyber Security Services is intensifying across sectors like IT/ITES, healthcare, pharmaceuticals, and manufacturing, with the banking and financial sectors particularly vulnerable. This urgency is driven not only by threats to businesses but also by a significant rise in citizen-centric cybercrimes in India during 2023-24, which highlights the critical need for robust Cyber security measures.



Citizen-centric cybercrimes have surged significantly, impacting daily life across India. Courier frauds have increased by over 67%, with scammers posing as legitimate companies to steal sensitive information. Investment frauds have risen by 58%, resulting in losses exceeding ₹12,000 crores through fake online schemes. Fake job offers have jumped by 55%, with fraudsters impersonating recruiters, causing financial and emotional harm. Impersonation scams on social media and messaging apps are up by 62%, with over 1,200 cases leading to losses of more than ₹500 crores.

Ransomware attacks have surged globally by 93%, heavily targeting the financial sector, with damages expected to reach \$30 billion by 2025. Phishing attacks now account for over 36% of data breaches, while supply chain attacks have risen by 42%, impacting industries dependent on intricate vendor networks.


# CYBER SECURITY FORUM PURPOSE AND OBJECTIVES

# TELANGANA STATE POLICE CENTRE OF EXCELLENCE FOR CYBER SAFETY (TSPCC)



By influencing policy development and fostering professional growth, this initiative will play a vital role in creating a secure digital environment for organizations and society.








CISO Council Eco System

The CISOs expressed their commitment to supporting the TSCSB's initiatives by offering their expertise in areas such as threat assessment, incident response, security audits, and awareness training. They also discussed the potential for ongoing collaboration, including the possibility of joint efforts to develop and implement advanced cyber security frameworks tailored to the specific needs of the bureau.

This meeting marked the beginning of a promising partnership aimed at strengthening the cyber security posture of the Telangana State Cyber Security Bureau, with the CISOs playing a pivotal role in providing guidance and support to meet the bureau's objectives.

# **SHE Shuttles**

#### PIONEERING SAFE AND RELIABLE TRANSPORTATION FOR WOMEN IN CYBERABAD

**SHE Shuttles** is an initiative launched by **SCSC** to provide last-mile connectivity and a safe transport option to women working in the Cyberabad limits.

SCSC launched SHE Shuttles Bus Services in Cyberabad for women employees in the IT corridor in the Cyberabad area with two buses on **June 29**, **2015**. To begin the operations, TSIIC donated two buses, and thereafter, many organizations came forward to support this initiative. The routes were planned to cover working areas and surrounding areas where several hostels are located, in addition to the majority of the IT Parks.

What started with **2 SHE Shuttles** is now **16 Shuttles** running with a monthly ridership of **1.52 lakhs.** 

SHE Shuttles is a unique initiative and one of its kind in the country for the working women professionals in the IT Corridor, rolled out for transit safety. SHE Shuttles runs on all the connecting roads where there is a concentration of IT companies and IT Parks connecting Hitech City, Madhapur, Gachibowli, Kondapur, Financial District and other areas. They run from 7:30 AM to 12:00 PM & 3:30 PM to 9:00 PM. With increased demand from Pharma clusters, during the past 4 years, launched **4 SHE Shuttles** in the Pharma area & services received an overwhelming response.

SHE Shuttles are tracked to ensure passenger safety. The system helps the user decide when to wrap up her office work and reach the bus stop just before the bus arrives, ensuring better safety on the road.

## WOMEN'S FORUM

The SCSC Women's Forum is committed to empowering women by creating awareness, fostering empowerment, and enabling them to create safe spaces for themselves. Over the past year, the forum has launched several impactful initiatives aimed at enhancing the safety and well-being of women in the society.

#### **Introduction of New Shuttle Services:**

To ensure safer transportation for women, four new shuttle services were introduced, supported by companies like Vestro, ADP, and Arcesium. These shuttles provide a reliable and safe commuting option for women, reducing transportation-related risks. These are over and above the existing SHE Shuttles, taking the total services to 15 now.

#### **Margadarshak Program:**

The Margadarshak program completed its **13th batch**, certifying 59 individuals who are now equipped to contribute to women's safety and empowerment. Throughout the year, 50 targeted interventions were conducted under this program to provide guidance and support, reinforcing the forum's commitment to a safer environment for women. 2023-2024 had seen about **60 interventions** by our Margadarshaks who have their presence in about **85 + organisations** in Hyderabad.

#### Sanghamitra Program:

The Sanghamitra program concluded its **3rd batch** with 13 new certified individuals. With a strong focus on community engagement, the program carried out **142 interventions**, educating and advocating for women's rights and safety within communities. We had **104 recorded interventions** last year which impacted about **104 lives**.

#### **Safety Awareness and Self-Defense Programs:**

Safety awareness remains a cornerstone of the SCSC Women's Forum's efforts. Over the past year, the forum conducted safety awareness sessions across **54 organizations**, reaching and educating **10,000 individuals** on personal safety, emergency preparedness, and resources available for women. Additionally, **self-defense programs** were held at 9 different organizations, empowering women with the skills needed to protect themselves.

#### **Future Initiatives:**

#### Going forward

The forum plans to continue its impactful work with several upcoming initiatives, including:

- Round Table Industry Meet on Women's Safety
- The SHE MPower Conclave 6.0,
- The launch of the upgraded SHE Safe APP.

Other planned activities include Project Safe Stay – a series of audits to ensure safe accommodations, and gender sensitization programs in schools to educate the next generation on equality and safety.

By continually expanding its range of programs and initiatives, the SCSC Women's Forum is dedicated to building a safer, more empowering environment for women everywhere.
