Greetings to all,

Unlike earlier years, we have decided to become environment friendly and decided to start the journey in submitting SCSC's annual report in e-format. All limited companies have switched to sending their annual reports in soft copy few years back.

It is a pleasure to present the annual report of SCSC. SCSC is a very unique organization set up anywhere in the country, in public private partnership, with Law Enforcement agencies at Cyberabad. I took over this volunteer position by end of May 2023. I work as Head of Strategy & Transformation - International CIO | Country Head - IT/CIO India for State Street. My other volunteer positions include, IT Advisor for Govt. of Telangana, on the boards of AMCHAM India & United Way India.

UPI has recorded 43.22 billion transactions as of July end of 2023 & the transaction value has crossed Rs. 83.15 trillion. With all the UPI transactions and other digital payments are increasing, while the instances of burglary & other petty crimes involving financial nature are on slight wane.

INDEPENDENT AUDITORS' REPORT

To the Members of SOCIETY FOR CYBERABAD SECURITY COUNCIL

Report on the Financial Statements

We have audited the accompanying financial statements of Society for Cyberabad Security Council ("The Society"), which comprise the balance sheet as at 31st March 2023, the income and expenditure account of the society for the year then ended, and summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

5TH WOMEN'S CONCLAVE & AWARDS 2023

On March 17, 2023, SHE M POWER--5th Women's Conclave & Awards 2023 event was held with the theme "Accelerate Safety & Well-Being in Sustainable World" at JRC Convention Centre, Film Nagar. More than 1000 delegates took part in the event.

Mr. Anjani Kumar, IPS, Director General of Police, Telangana; Mr. Stephen Raveendra, IPS, Commissioner of Police, Cyberabad; Ms. Jennifer Larson is the Consul General in Hyderabad; Dr. Gurunath Reddy, CMD, Continental Hospitals, Mr. Krishna Yedula, Secretary General, SCSC; Ms. Nikita Pant, IPS, DCP-Women and Child Safety; Ms. Pratyusha Sharma, Jt. Sec Women's Forum, SCSC graced the conclave and spoke.

DGP Sri Anjani Kumar launched the 16th and 17th SHE Shuttle Bus Services sponsored by Virtusa and Providence contributing to serving one lakh women commuters every month.

Addressing the gathering Mr. Anjani Kumar, DGP said with safety protocols in place, technology will be a wonderful servant. Cultivate the culture of protocols.



Dr Gurunath Reddy, CMD of Continental Hospital gave the keynote address. He gave some convincing facts about how women are superior to men. Women's brains work five times faster than men's. MR.I shows that 70% of neurons in women's brains light up much faster to perform multiple tasks than men. Women proved to have more endurance than men in the case of the 195 km long run. No man could ever beat that record. Women have higher physical endurance. Women are healthier, they live longer. Their muscle fiber is stronger and makes them better long-distance runners and bikers. Less women are diabetic, fewer women suffer cancer. They get fewer infectious diseases. Men get more flue attacks than women, he said much to the surprise of the audience.

Mr. Stephen Raveendra IPS, Commissioner of Cyberabad Police said the theme of the conclave is vital to society. We have come a long way in women related matters, but still long way to go. Women's rights are still challenged. One of the few challenges is the financial well-being of women. The women are financially excluded and discriminated. Education is the cornerstone for women's empowerment. We see girls excelling more than boys in tenth standard results but subsequently dropping out. Only 9% of co-founders of startups are women. Wellbeing of a woman is another critical component. He urged corporations to pay more attention to the wellness of women employees. Time for change is now, he said and concluded his speech.

Welcoming the gathering Ms. Pratyusha Sharma, SCSC Women's Forum leader said the theme was chosen carefully. How do we accelerate safety, and well-being in a sustainable world by always paying due respect to women, helping them rise and helping them voice and ensure the message reaches more. She reported that till date 1500 Margadarshaks and Sanghamitras

were trained, and up to 850 cases were reported. SCSC's women's forum conducted knowledge-sharing and safety sessions that covered around 60,000 people. To enable women employees to look for safe hostels, SCSC published a list of safe hostels that were certified by SCSC and Cyberabad police as per the 10 commandments.

Krishna Yedula said SCSC is the single largest touch point serving two million workforces. SCSC's scale, size and impact has grown. It has been playing a catalyst role for so many years. She Shuttle services which started with one has now gone to 17 and demand is increasing.

Two Panel discussions were held. One was on Vision for SCSC was moderated by Krishna Yedula. The panelists include Apoorva Rao, IPS., SP Nalgonda Dr Ramadevi - Amara Hospitals Anil Rachamalla - End Now Foundation.

The second panel was on Sustainability as a way of Life for a balanced Ecosystem. It was moderated by Padma Priya. Swaraj Priyadarshi, Dexterity Global 2. Elca Grobler and My Choices Foundation were the two panelists.

A fireside chat was held with Murali Krishna, Country Head-Providence, moderated by Pratyusha Sharma on the Health & Mindset of Women in the Workplace.



CYBERSECURITY FORUM REPORT

Jt. Secretary: Abhishek Kumar

Convenor: Kalmeshwar Shingenavar, DCP - Crimes

The demand for Cyber Security related services is increasing from all industries and sectors like Healthcare, Pharma, manufacturing etc. The demand for enhanced maturity related to adoption of technologies, techniques etc., has been experienced more from the Banking and Financial Sectors. Hence the Cyber Safety and Security were identified as one of the core pillars for SCSC and Cyberabad Metropolitan Police.

Purpose and Objectives

SCSC's Cyber Security forum will serve as a central hub for cybersecurity professionals, experts, organizations, and other stakeholders to exchange ideas. The primary objectives of the forum are:

- 1. Knowledge sharing: Facilitate the sharing of cybersecurity insights, trends, research, and best practices to enhance collective understanding and awareness.
- 2. Collaborations & Partnerships: Foster collaborations and partnerships between industry, academia, banking & finance sectors, and other relevant entities to address cyber security challenges through joint initiatives, projects, and information sharing.
- 3. Capacity Building: Promote capacity building in the field of cybersecurity through workshops, training programs and educational events.
- 4. Public Awareness: Raise public awareness about threats, risks and preventive measures through campaigns, seminars, and citizen outreach programs.

Cyber Security Forum's flagship program, DiLSeY (Digital Literacy to secure Youth) has been on the forefront in spreading awareness on cybercrimes, covering various sectors viz., Educational Institutes, Corporates, Hospitality Industry, Aviation, Armed Forces, NCC Cadets, Defence Sector, Construction workers, etc.,

Keynote Speaker: Steve Pugh serves as Chief Information Security Officer (CISO) for ICE Data, which owns the NYSE – New York Stock Exchange. Before joining ICE Data, Steve has worked with 3 past presidents of USA and advised them on national security and cyber security related areas. The meeting was well attended by CISOs from various industries like IT, ITES, Pharma, Retail & Hospitals. This event brought together leading cyber security experts and professionals from various industries to discuss cyber security strategies and best practices. Addressing the gathering Mr. Krishna Yedula, Secretary General, SCSC said "SCSC is envisioning to work with the CISOs for the common cause of Cyber Safety & Security of the Industry. We invite CISOs to come forward and share the knowledge for the benefit of the society".

Addressing the gathering of CISOs, Commissioner of Police Mr. Stephen Raveendra, IPS said "The threats posed by cyber criminals is evolving at an alarming rate and Police is constantly adapting to address these threats. All cyber criminals work in organized manner through gangs and only way to counter this, is all good, knowledgeable professionals should join hands with Police and work together for the benefit of the society. He congratulated all the CISOs for doing and excellent job of protecting the assets of the organizations and with the same enthusiasm & dedication you should put efforts to help the nation protecting the country's assets. He further mentioned that TSPCC is thinking of setting up a CISO council to work together and take the initiative forward. He urged everyone to share the best practices adapted in organizations which is a win-win situation for all of us."

Journalism in the Digital Age is Tough - Fact or Fiction?

A conference on challenges to the new-age digital journalism was held at the Cyberabad Commissionerate on Saturday, 13th Mar 2023. It was jointly organized by SCSC in association with TSPCC and supported by End Now Foundation.

The conference emphasized the need to improve the credibility of news, equip journalists with tools to do fact-checking to ensure the validity of information before they publish it and understand how to identify and differentiate between misinformation and disinformation.

Speaking of misinformation, Soma Shekar, a former journalist at The Hindu said, "Even though I have 20 years of experience in journalism, it is overwhelming to witness the age of digital media. Journalism in the digital age is tough and there is a need to differentiate between fact and fiction. Choosing what to believe and what not to is a major challenge today."

The veteran scribe then highlighted the changing trends in journalism, "In the 1990s, print and radio were main modes of communication. It involved a reporter going to the field, then the subeditor used to edit the news item which was reviewed by the news editor, and this is how the gatekeeping was practiced.

The only visual element in the whole exercise was the photograph, the photographer visited the spot. A photograph is worth a thousand words", he said.

Commissioner of Police, Cyberabad, Mr. Stephen Raveendra IPS then focused on differentiation between misinformation and disinformation. He said, in today's age of information disorder, as representatives of law enforcement and digital media, we share an enormous responsibility to address this problem head-on, and it should be ensured that the integrity of the truth prevails. He explained the seven forms of common information disorder that prevail and how they can have disastrous impacts on our society, politics, economies and indeed, the very fabric of our democracy.

Krishna Yedula, Secretary General of the Society for Cyberabad Security Council (SCSC), one of the organizing partners and active contributors then explained how the presence of unverified information in the digital domain also leads to cybercrime issues and called on the journalists to do their part in verifying before publishing.

This was followed by a session on Digital Intelligence by Anil Rachamalla, founder of End Now Foundation. He spoke about the concept of digital intelligence and how it can be leveraged by journalists to gather and analyze information for effective reporting, by showing them practical examples of deep search on search platforms.

Dr Sonia Sharma, a psychiatrist, stressed on the factors affecting mental health of journalist and said, "Internet might fail but the brain stores all the information, which helps decide what is to

be put out on the digital platforms. It also helps decide whether the information shared would be real or fake."

In the face of the growing menace of fake news, Rakesh Dubbudu, founder of Factly, a fact-checking news platform, conducted a session on fact-checking at a workshop for digital media journalists. The workshop, titled Challenges in the New Age of Digital Journalism, took place at the Cyberabad Police Commissionerate on Saturday.

Rakesh Dubbudu provided live examples of how fake news can be created, published, and lead to communal riots and public order disturbances. He stressed the need for independent journalists to validate their information and ensure that their pieces are supported by reliable sources. Various plat- forms and tools were introduced to aid journalists in the verification process.

Supreme Court advocate Sai Teja Kaveti expounded the Articles of the Constitution that gives Right of Freedom of Expression and added the caveat of reasonable restrictions. Times of India Special Editor Sushil Rao spoke about the ethics of journalism and explained how it was the duty of journalists not to create rumors or disseminate them, but to bust rumors and myths by going to the root of the matter.

Siasat Editor Zahiruddin Ali Khan said sanitizing social media platforms with respect to fake news is a fight that all journalists must be a part of.


Vision:
